COMES NOW Greeley Gas Company, a division of Atmos Energy Corporation ("Greeley"), pursuant to 4 CSR 240-2.080, and respectfully state as follows:

- 1. On November 21, 2001, in its Motion For Extension Of Time And For Expedited Treatment, the Staff, citing unexpected delays related to contracting with its outside consultant as well as data format problems, requested an extension of the time to file its recommendation in this case from December 4, 2001 until January 18, 2002.
- 2. In its Second Order Directing Filing, issued on November 27, 2001, the Commission, among other things, ordered Greeley to file its response to the Staff's request for extension, and Staff to file a revised procedural schedule by November 29, 2001.
