PROPOSED REVISED PROCEDURAL SCHEDULE

COMES NOW the Staff ("Staff") of the Missouri Public Service Commission ("Commission"), and respectfully states as follows:

- 1. On March 2, 2001, the Commission issued its Order Setting Prehearing Conference and Requiring Filing of Procedural Schedule, wherein the parties to this case were directed to file, no later than April 4, 2001, a proposed procedural schedule to address the Purchased Gas Adjustment Factors of Greeley Gas Company ("Greeley" or "Company") to be Audited in the Company's 2000-2001 Actual Cost Adjustment ("ACA").
- 2. Pursuant to the Commission's directive, the parties proposed that the following procedural schedule be established:

July 16, 2001	Greeley makes its 2000-2001 ACA books and work papers available to Staff for audit
July 31, 2001	Greeley answers Staff's standard DRs (forty-nine in number)
December 4, 2001	Staff Recommendation
January 4, 2002	Company Response
February 5, 2002	Direct Testimony (all parties wishing to file)
March 7, 2002	Rebuttal Testimony (all parties wishing to file)

March 14, 2002

Issues List to be filed

March 21, 2002

Position Statements (all parties)

April 1, 2002

Surrebuttal Testimony (all parties wishing to file)

April 8, 2002

- 3. The Commission adopted the proposed procedural schedule in an order dated April 10, 2001.
- 4. On November 21, 2001, in its Motion For Extension Of Time And For Expedited Treatment, the Staff, citing unexpected delays related to contracting with its outside consultant as well as data format problems, requested an extension of the time to file its recommendation in this case from December 4, 2001 until January 18, 2002.
- 5. In its Second Order Directing Filing, issued on November 27, 2001, the Commission, among other things, ordered the Staff to file a proposed revised procedural schedule that incorporates the requested extension of time to file its recommendation. Accordingly, the following schedule is hereby proposed for the remaining events in the schedule.
