

THIRD ORDER DIRECTING RESPONSE

This order sets the time for Greeley Gas Company's response to the Staff's recommendation.

On January 18, 2002, the Procurement Analysis Department of the Staff of the Commission filed a memorandum indicating that Staff has reviewed the 2000-2001 Actual Cost Adjustment (ACA) filing of Greeley Gas Company. Staff audited the billed revenues and actual gas costs for the period of June 2000 through May 2001, included in Greeley's computation of the ACA rate. Staff stated that based upon its review certain adjustments to the ACA balances are necessary. Staff also recommended some additional actions for Greeley to take prior to October 1, 2002. Finally, Staff recommended that the Commission issue an order requiring Greeley to respond to its recommendation within 30 days.

The Commission has reviewed the memorandum filed by Staff. The Commission determines that Greeley should file a response to Staff's recommendation no later than 30 days from the date of this order.

1. That Greeley Gas Company shall file a response to the recommendation of the Staff of the Commission no later than March 4, 2002.
2. That this order shall become effective on February 10, 2002.
