Pursuant to 20 CSR 4240-28.011(2), Consolidated Communications of Missouri Company, LLC ("the Company") respectfully requests that the Missouri Public Service Commission ("Commission") acknowledge its adoption of the Fidium fictitious name. The Company is in good standing with the Missouri Secretary of State, in compliance with the Commission's Annual Report requirements, and current with its applicable Missouri USF and Commission assessments. The Company has reviewed its contacts on the Commission's electronic filing and information system (EFIS), and they have been updated as needed.

The Company is an Eligible Telecommunications Carrier (ETC) and will continue to comply with all applicable laws and rules relating to the ETC designation.

1. General

- a. Community Optional Service (COS) is an optional plan that allows customers in a qualifying COS Petitioning Exchange to purchase intraLATA interexchange calling with customers in designated exchanges, known collectively as their COS Calling Scope, under terms, conditions and rates as found in the Company Tariff(s). The COS Calling Scope consists of the COS Target Exchange to which COS Petitioning Exchange customers have qualified for COS calling, plus all other exchanges with which customers in the COS Target Exchange have Extended Area Service (EAS).

2. Qualification Process

- a. In order to qualify, customers in one exchange, known as the COS Petitioning Exchange, must demonstrate that a community of interest exists with customers in the exchange with which they desire COS calling, known as the COS Target Exchange. Consideration of eligibility for COS calling is initiated by a petition filed with the MPSC by any or all of the following parties:
- 1) By 25 or more customers in the COS Petitioning Exchange;
 - 2) By the presiding official(s) of a city, town, village or county, within the COS Petitioning Exchange;
 - 3) The Office of the Public Counsel on behalf of the customers in the COS Petitioning Exchange;
 - 4) The company serving the customers in the COS Petitioning Exchange.
- b. If the petitioning COS Exchange has failed the calling study criteria, the exchange can reapply or repetition for the service after two (2) years.
- c. COS will not be offered between Metropolitan Calling Area (MCA) exchanges as defined in the Missouri Public Service Commission (MPSC) Order, effective January 5, 1993, in Case #TO-92-306.
- d. Petitions requesting COS must specify the COS Target Exchange with which COS calling is requested. The COS Target Exchange may be served by another local exchange company.

- e. Upon issuance of a MPSC Order directing a calling study, the Company will conduct a study covering a one month billing period of Long Distance Message Telecommunications Service Dialed Station-to-Station traffic from the COS Petitioning Exchange to the COS Target Exchange.
 - f. The MPSC has ruled that a community of interest is found to exist when the traffic studies show that both of the following criteria are met:
 - 1) Customers in the COS Petitioning Exchange make an average of at least six calls per access line per month to the COS Target Exchange;
 - 2) Two-thirds of the customer in the COS Petitioning Exchange make two or more calls per month to the COS Target Exchange.
 - g. If the above criteria have been satisfied and/or the MPSC determines that a community of interest exists, the COS Petitioning Exchange will be certified as a COS qualifying exchange and the service will be implemented on a time schedule approved by the MPSC.
3. Conditions
- a. COS will be offered as a two-way optional flat rate service. Two-way optional flat rate service allows customers to make unlimited calls to and receive unlimited calls from the COS Target Exchange Calling Scope for a recurring monthly flat rate.
 - b. The Calling Scope of the two-way COS route shall be to the COS Targeted Exchange plus its EAS exchanges. Any EAS additives applicable in the COS Target Exchange would apply to the COS subscriber in addition to the COS monthly flat rate.

- c. In addition, a Noncontingous Exchange Additive charge (NEAC) may be applicable for Metropolitan COS routes between noncontiguous exchanges, see Rates and Charges.
- d. Qualifying exchanges and their corresponding COS Target Exchanges are specified in this Tariff, COS Target Exchanges are classified as Rural or Metropolitan by the MPSC.
 - 1) The St. Louis and Kansas City exchanges (MCA-Central, MCA-1 + MCA-2) and Springfield exchanges (MCA-Central) + MCA-1) have been designated to be Metropolitan. All other COS Target Exchanges have been designated Rural.
- e. Unless otherwise specified in these conditions, COS is offered to all classes and grades of residence and business customers located in a COS qualifying exchange on a per line basis.
- f. COS is not offered in conjunction with Cellular, Public, Semi-Public Coin Box, Customer Owned Pay Telephone Services or comparable services offered by other local exchange companies in their exchanges listed in this Tariff.
- g. When a customer's telecommunications service is arranged for his or her own administrative use, versus use by his or her patrons (such customers may include, but are not limited to hotel/motels, hospitals or universities), COS may be purchased for the administrative trunks only.
- h. With the exception of Shared Tenant Service, COS is not to be shared or resold.
- i. COS customers listed in the COS Petitioning Exchange Company directory will be listed in the COS Target Exchange white page directory at no extra cost.

Subscription to COS does not entitle that customer to free copy of the white page directory of the COS Target Exchange.

j. For COS routes terminating in an MCA exchange, the Calling Scope will only include the targeted MCA exchange plus EAS with that exchange.

k. Rates Application

- 1) The monthly rates apply on a per line basis except for Centrex or similar type Services billed on a PABX or equivalent type service as specified in the General and Local Exchange Tariff of the local exchange company providing basic local service to the COS subscriber. The monthly rates are billed one month in advance.
 - 2) COS rates and charges are in addition to all other rates and charges paid by a subscriber for all other services of the exchange company providing basic local exchange service to the COS subscriber.
 - 3) COS must be purchased on all access lines for an account which is combined billed.
 - 4) If a customer subscribes to both COS and OCA, where the COS Target Exchange is within the subscriber's OCA calling scope, the COS rates and charges apply to qualified COS calls to the Target Exchange. The OCA rates and charges do not apply to such calls.
- l. The minimum service period for subscription to COS is one month.
- m. The exchange company providing basic local exchange service in each exchange has the option to determine whether this service will be dialed on either a 1+(NXX-XXXX) or on a seven digit dialing basis.
- n. COS is available on a dial station-to-station basis only.

- 1) The Outstate Calling Area (OCA) Plan is an optional one-way Dial Station-to-Station Message Telecommunications Service (MTS) for customers in selected exchanges.
- 2) The OCA Plan offers discounted block of time calling beyond a customer's local exchange to rate centers that fall within the Calling Scope.
- 3) The local exchange company providing basic local exchange service in each exchange has the option to determine whether this service will be dialed as either 1+ (NXX-XXXX) or on a seven digit basis.

b. Service Availability

- 1) Customers in exchanges within the Kansas City Metropolitan Calling Area (MCA), other than MCA-5 exchanges, are not eligible to subscribe to the OCA Plan.

c. Calling Scope

- 1) The Calling Scope for an OCA exchange includes all intrastate intraLATA toll rating points within a 23-mile radius. The 23 mile radius, from each exchange, is based on air miles and is measured from rate center to rate center, as defined in this Tariff.
- 2) Customers in Kansas City MCA-5, St. Louis MCA-5 and Springfield MCA-2 exchanges will be able to subscribe to the OCA Plan; however, the 23 mile radius will not include any toll rating points within the MCA. Refer to the Missouri Public Service Commission (MPSC) Order, effective January 5, 1993, in Case # TO-92-306.

d. Calling Options

Residential and Business customers can choose two OCA options. Rates are listed in this Tariff and are in addition to the established charges for the service with which the OCA Plan is associated. OCA subscribers are charged the full monthly rate for the block of time selected, even if the full block of time is not used.

- 1) Two-hour block of time: This option allows subscribers two hours of calling per month at a flat rate. MTS rates are applicable for calls exceeding the two hours.
- 2) Five-hour block of time: This option allows subscribers five hours of calling per month at a flat rate. An additional per minute rate, as identified in Rates, applies for all calls exceeding the five hour block. Time of day and holiday discounts are not applicable.

2. Regulations

- a. Unless otherwise specified in these regulations, OCA is offered to all Classes and grades of residence and business customers located within the eligible OCA exchanges.
- b. OCA is not offered in conjunction with Cellular, Public Semi-Public, or Customer-Owned Pay Telephone Services, or comparable service offered by other local exchange companies in their exchanges listed in this Tariff.
- c. OCA is not to be shared or resold.
- d. OCA is available to multiline customers on a per account basis only.
- e. Time of day and holiday discounts are not applicable for calls within the block of time.
- f. Rate Application
 - 1) The minimum service period for subscription to OCA is one-month.
 - 2) A customer may purchase only one block of time per month.
 - 3) The monthly charges for an OCA block of time will be charged on a per account basis and are billed in advance.
 - 4) OCA rates and charges are in addition to all other rates and charges paid by a subscriber for all other services of the local exchange company providing basic local exchange service to the OCA subscriber.
 - 5) If a customer subscribes to both OCA and Community Optional Service (COS), where the COS Target Exchange is within the subscriber's OCA Calling Scope, the OCA rates and charges do not apply to qualified COS calls to the Target Exchange. The COS rates and charges do apply to such calls.
