Dear Secretary Dippell:

Zayo Northeast, LLC (the "Company") hereby notifies the Missouri Public Service Commission of the Company's legal name change to "Zayo Network Services, LLC".

The Company is a Delaware limited liability company and is authorized by the Commission to provide non-switched local telecommunications services and interexchange telecommunications services, granted in File No. TA-2025-0242 effective April 18, 2025. The name change documents filed with the Delaware Secretary of State are provided as **Attachment A** and the Company's amended authority to transact business in Missouri is provided as **Attachment B**.

The Company's legal name change does not entail any merger or other transaction disrupting the existence of the Company.
