On January 18, 2021, Spire Missouri Inc. filed a motion to modify the Commission's December 2, 2020 *Order Modifying Temporary Waiver and Directing Written Notice*. Spire requests the Commission extend the period of waiver from March 31 to October 31, 2021. In addition, Spire requests the Commission remove a one-year limit on noncompliance for any location, which is required as a condition of waiver by the Commission's June 11, 2020 *Order Approving Application for Temporary Waiver and Directing Written Notice*. Spire requests expedited treatment and asks the Commission to issue its order no later than January 30, 2021, to provide the mandated 60 days' notice¹ to the U.S. Department of Transportation before an order would take effect on April 1, 2021.

The Commission will direct Staff to file an expedited recommendation by no later than 10 a.m. January 25, 2021, and will direct Spire to respond to Staff's recommendation. Any response to Staff's recommendation may be filed no later than 10 a.m. January 26, 2021.
