## ORDER ESTABLISHING TIME FOR SPIRE MISSOURI, INC. TO FILE PROGRESS REPORT

Issue Date: January 19, 2021 Effective Date: January 19, 2021

On December 30, 2019, at the request of its Staff, the Commission opened this investigation into the recordkeeping, business practices, business operations, and responsiveness to the Commission of Spire Missouri, Inc. (Spire). Staff completed its investigation and filed its report and recommendations on October 30, 2020.

Staff reports that its investigation analyzed Spire's call center operations, quality assurance and employee training practices, metering operations, and responsiveness to the Commission and Staff. Staff's investigation revealed several areas of concern, and Staff recommends the Commission direct Spire to file a formal implementation plan to address each of the recommendations offered by Staff. Further, Staff asks that Spire be directed to file bi-annual status reports describing its progress in implementing its plan.

The Commission ordered Spire responded to Staff's report and recommendations with an implementation plan and to file the bi-annual progress reports requested by Staff. Spire filed that implementation plan on December 18, 2020. The Commission will now establish a date for Spire to file the bi-annual progress reports recommended by Staff. The first such progress report shall be filed six months after December 18, 2020

#### THE COMMISSION ORDERS THAT:

- 1. No later than June 18, 2021, Spire shall file a report describing its progress in implementing the implementation plan it filed on December 18, 2020.
- 2. Thereafter, Spire shall file additional progress reports on December 18 and June 18 of subsequent years until otherwise ordered by the Commission.
  - 3. This order shall be effective when issued.
