ORDER CANCELING CERTIFICATE AND TARIFF

Issue Date: January 20, 2021

Effective Date: February 1, 2021

On September 24, 2018, the Receiver for Ridge Creek Water Company, LLC (RCWC) and Ridge Creek Development Company, LLC (RCDC) filed an application (Application) with the Commission. The Application sought authority for the Receiver of those companies to sell its water system to the City of St. Robert.

On November 15, 2018, the Commission granted the Application. The order granting the Application required the Receiver to notify the Commission once the sale was closed. After receiving such notice, the order further stated that the Commission would cancel the relevant certificates and tariffs held by RCWC.

On October 7, 2020, the Receiver notified the Commission that the sale was complete. Thus, the Commission will cancel RCWC's certificate and tariff.

THE COMMISSION ORDERS THAT:

1. The certificate of convenience and necessity granted to RCWC in File No. WA-2015-0182 is canceled.
2. RCWC's tariff, Tariff No. YW-2016-0094, is canceled.

3. This order shall be effective on February 1, 2021.
