## ORDER ESTABLISHING TIME TO RESPOND TO MOTION

On January 19, 2021, the Staff of the Missouri Public Service Commission (Staff) filed a motion requesting that the Commission cancel the certificate of interexchange service authority of Silv Communication, Inc. (Company). The Commission granted the Company the subject certificate to provide intrastate interexchange service in File No. XA-2009-0301 on March 30, 2009. The Staff's motion states that the Company wishes to voluntarily relinquish its authority. The Company does have an applicable tariff, Tariff No. YX-2009-0592.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed ten days from the issuance of this order to file a motion for hearing.


