**ORDER ESTABLISHING TEST YEAR**

The Commission set a time for responses to the test year and true-up period proposed by Spire Missouri Inc. No party has objected or otherwise responded to the proposed test year of the twelve-month period ending September 30, 2020, or to the proposed true-up date of May 31, 2021. The Commission finds the proposed test year to be reasonable and will establish it as the test year, with the requested true-up period.

**THE COMMISSION ORDERS THAT:**

1. The test year for Spire Missouri Inc.'s request to implement a general rate increase for its natural gas service shall be the twelve-month period ending September 30, 2020, adjusted for known and measurable changes, to be trued-up through May 31, 2021.
2. This order shall be effective upon issuance.
