ORDER GRANTING VARIANCE AND ORDER APPROVING INTERIM RATES

Atmos Energy Corporation filed a tariff sheet with the Commission on June 15, 2001, carrying an effective date of July 1, 2001. The tariff sheet reflects an unscheduled Summer Purchased Gas Adjustment (PGA) change reducing the cost of gas, rather than waiting until Atmos' next scheduled Winter filing. This unscheduled Summer PGA filing applies to Atmos' service area previously served by Associated Natural Gas Company.

Additionally, Atmos filed a pleading requesting the Commission grant a variance from its tariff provision to permit Atmos to file this unscheduled Summer PGA. Atmos stated that good cause exists for granting Atmos a variance from its PGA tariff provision because of recent reductions in natural gas prices. Atmos stated that it is reasonable and appropriate to file an unscheduled Summer PGA filing because 1) it will give a more accurate price signal to consumers regarding the current cost of natural gas, and 2) reducing the cost of gas will help keep the Deferred Carrying Cost Balance (DCCB) and the ACA balances at appropriate levels and not create significant over-collections or under-collections.

On June 26, 2001, the Staff of the Missouri Public Service Commission filed its recommendation that the Commission approve Atmos' proposed tariff sheet for service on and after July 1, 2001, as an interim rate, subject to refund. Staff also recommended that Atmos' request for a one-time variance from the PGA clause of its tariff be granted.

For Atmos' Butler District, the effect of these changes will decrease the firm PGA factor for the remainder of the 2001 summer season to \$0.67077 per Ccf from a winter season firm PGA factor of \$1.16519 per Ccf. For Atmos' Kirksville District, the effect of these changes will decrease the firm PGA factor for the remainder of the 2001 summer season to \$0.78998 per Ccf from a winter season firm PGA factor of \$1.07076 per Ccf. For Atmos' SEMO District, the effect of these changes will increase the firm PGA factor for the remainder of the 2001 summer season to \$0.79986 per Ccf from a winter season firm PGA factor of \$1.13726 per Ccf.

Staff stated that, with exception of the one-time variance request to file an unscheduled summer PGA, this filing was calculated in conformity with Atmos' PGA Clause. Staff further stated that Atmos' PGA Clause allows for ten business days' notice for filings reflecting PGA changes and that, under the circumstances, good cause exists to approve the proposed tariff sheet on less than 30 days' notice. Staff recommended that the Commission approve the tariff sheet to become effective July 1, 2001, on an interim basis, subject to refund, pending a final Commission decision in Atmos' ACA Case Nos. GR-98-399, GR-99-392, GR-2000-573 and GR-2001-396.

The Commission has reviewed the proposed tariff sheet and Staff's Memorandum and Recommendation. The Commission finds that the tariff sheet conforms to the company's Commission-approved PGA Clause and is therefore reasonable. This

unscheduled decrease in Atmos' rates is necessary because of the recent reductions in natural gas prices. The Commission also finds that it is reasonable to grant Atmos' request for a one-time variance from Atmos' PGA tariff clause.

After considering Staff's recommendation, and for good cause shown pursuant to Section 393.140(11), RSMo 2000, the Commission concludes that the proposed tariff sheet should be approved to become effective on and after the requested effective date of July 1, 2001, interim subject to refund.

IT IS THEREFORE ORDERED:

- That the Request for Variance From Tariff Provisions filed by Atmos Energy
 Corporation on June 15, 2001, shall be granted.
- 2. That Tariff No. 200101191, submitted in Case No. GR-2001-396, by Atmos Energy Corporation, is approved on an interim basis, subject to refund, for service rendered on and after July 1, 2001. The tariff sheet approved is:

3. That this order shall become effective on July 1, 2001.


