ORDER CANCELING REGISTRATION

Issue Date: January 27, 2021

Effective Date: February 6, 2021

On January 12, 2021, Telecommunications Management, LLC d/b/a NewWave Communications (NewWave) filed a letter seeking to cancel NewWave's registration to provide Video Service in the State of Missouri. The Commission granted NewWave's registration in the State of Missouri in File No. KA-2012-0143.

On January 27, 2021, Staff filed a recommendation in support of the cancellation of NewWave's Video Service registration.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹

Based on NewWave's request and Staff's recommendation, the Commission finds that the Video Service registration granted to NewWave, shall be canceled.

THE COMMISSION ORDERS THAT:

1. The registration to provide Video Services granted to NewWave, in File Number KA-2012-0143, is canceled.
2. This order shall become effective on February 6, 2021.
