ORDER APPROVING TARIFF

On September 24, 2025, Spire Missouri Inc. d/b/a Spire filed Tracking No. JG-2026-0039. Spire filed the tariff to implement new rates as permitted by the Commission's September 3, 2025 Order Approving Stipulation and Agreement (Order). That Order approved a stipulation which, among other things, allowed Spire to file a compliance tariff bearing an effective date of October 24, 2025. On September 29 and September 30, Spire filed substitute tariff sheets for Tracking No. JG-2026-0039.

The Commission's Staff filed a Recommendation on October 8, 2025, stating that the Commission should approve the tariff. No other responses were received.

The Commission has reviewed the tariff and Staff's recommendation. Based on these filings, the Commission finds that the tariff comply with the Order.

The Commission approves the tariff as ordered below. As the tariff is unopposed, and so that this tariff may go into effect expeditiously on the

requested effective date, the Commission will make this order effective in less than thirty days.

THE COMMISSION ORDERS THAT:

1. Tracking No. JG-2026-0039, submitted on September 24, 2025, substituted on September 29, 2025, and substituted on September 30, 2025, is approved to become effective on October 24, 2025.
2. This order shall become effective on October 24, 2025.
