JOINT RESPONSE TO ORDER

On July 22, 2025, the Staff of the Commission (Staff) filed a motion requesting the Commission cancel the registration to provide Interconnected Voice over Internet Protocol (IVoIP) services for ConnectMe, LLC (ConnectMe). That motion created the instant case. On the same day, the Commission issued an *Order Establishing Time to Respond*, granting until August 1, 2025 for anyone wishing to respond to Staff's motion to do so.

On August 1, 2025, Cloudli Communications, Inc., (Cloudli) filed its *Response to Staff's Motion to Cancel Registration*. Cloudli is the successor in interest to ConnectMe, LLC. Also on August 1, 2025, Cloudli filed its own Application for IVoIP Registration with the Commission in File No. DA-2026-0032. That Application was granted by the Commission on August 18, 2025.

On October 6, 2025, the Commission issued an *Order Directing Filing* in this case, stating that "Any party who objects to the Commission canceling the IVoIP registration of ConnectMe shall respond no later than October 20, 2025."

In the meantime, Cloudli has paid to the Commission the past-due assessments cited in the Staff Motion that created this case, and Staff and Cloudli have agreed that no further actions are required by Cloudli on behalf of

ConnectMe to satisfy Staff's requirements. Cloudli now has its own Missouri IVoIP Registration and is expected to meet all reporting requirements going forward.

As a result, Cloudli, as successor in interest to ConnectMe, and Staff agree that the IVoIP Registration granted to ConnectMe in Case No. DA-2016-0004 may be cancelled by the Commission.

WHEREFORE, Staff and Cloudli Communications Inc. respectfully request that the Commission cancel the Missouri IVoIP Registration of ConnectMe LLC..
