ORDER RECOGNIZING NAME CHANGE

On October 2, 2025, Zayo Northeast, LLC submitted a request to recognize its name change to Zayo Network Services, LLC. The company was authorized to provide non-switched local and interexchange telecommunications services in Case No. TA-2025-0242.

The Commission has reviewed the filings and 20 CSR 4240-28.011(2) and finds the company has complied with all statutory and regulatory requirements for changing its name. The Commission will recognize the name change and approve the adoption notice and revised tariff title sheet.

The Commission finds it reasonable for this order to become effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of Zayo Northeast, LLC to Zayo Network Services, LLC.
2. This order shall become effective on October 25, 2025.
3. This case shall close on October 26, 2025.

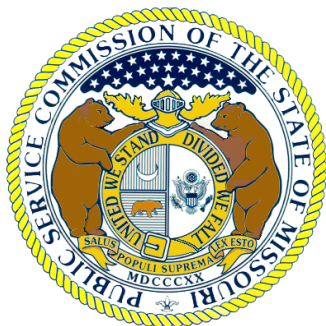
