Dear Secretary of the Commission:

Southwestern Bell Telephone Company, d/b/a AT&T Missouri, is revising P.S.C. Mo.-No. 35, General Exchange Tariff in accordance with AT&T Missouri's Notice of Election Of Waivers filed on August 28, 2008, in Case No. IE-2009-0082 ("Notice").

AT&T Missouri's Notice informed the Commission that AT&T Missouri elected to opt out of the application and enforcement of certain Commission rules and statutes pursuant to Section 392.420 RSMo., as amended by HB 1779, effective August 28. AT&T Missouri also stated in its Notice that, prior to October 28, it would make an administrative tariff filing to list the elected waivers. AT&T Missouri delayed this filing to reduce the work load on Commission personnel that was anticipated to occur beginning August 28 as HB 1779 became effective. With this tariff filing, AT&T Missouri includes in its General Exchange Tariff the same Commission rules and state statutes whose application and enforcement AT&T Missouri elected to waive.

The proposed tariff changes are reflected on the attached tariff sheets with issued and effective dates of October 17, 2008 and November 16, 2008, respectively.
