ORDER APPROVING WNAR TARIFF

Issue Date: October 17, 2025 Effective Date: November 1, 2025

On September 2, 2025, Union Electric Company d/b/a Ameren Missouri filed a tariff for its Weather Normalization Adjustment Rider. That tariff bears an effective date of November 1, 2025. The purpose of the tariff is to adjust revenues for differences between actual heating degree days (AHDD) and normal heating degree days (NHDD).

On October 15, 2025, the Staff of the Commission (Staff) filed its recommendation. Staff reviewed the tariff sheet and recommended that the Commission approve it. Staff states that residential customers using 100 ccf in a given billing month will see an estimated \$2.66 decrease in their bill from the current WNAR rate. No other responses to the tariff sheets were filed in the time set by the Commission.

The Commission has reviewed the tariff and Staff's recommendation and finds that the tariff should be approved. In addition, the Commission finds it reasonable to make this order effective in less than thirty days so that the order will be effective concurrently with the tariff. Therefore, the Commission will approve this tariff to become effective on November 1, 2025.
