**NOTICE OF ERRATA TO THE REBUTTAL
TESTIMONY OF LEAH DETTMERS**

1. On August 14, 2025, the Company filed the rebuttal testimony of Leah Dettmers (Rebuttal Testimony or Dettmers' Rebuttal Testimony).

2. After filing, Ms. Dettmers discovered inadvertent typographical errors in her Rebuttal Testimony that need to be corrected, as follows:

Page 21, Line 14	"that 'it did not <u>didn't</u> include any of my property within that map.'"
Page 21, Line 16	"the line was going as depicted by the skinny line on the maps <u>map</u> that was advertised."
Page 22, Line 22	"(Harding <u>Dir.</u> at 4, lines 27-28)"
Page 23, Lines 9, 11, and 13	Changed "Harding" to "Mathews"

3. Attached hereto is a full, clean copy of Ms. Dettmers' corrected Rebuttal Testimony in Confidential and Public Redacted versions.

4. ATXI does not believe that submitting these corrections will prejudice any party's ability to address Ms. Dettmers' testimony at hearing.
