ORDER DIRECTING EXPEDITED STAFF RECOMMENDATION ON REVISED TARIFF SHEET AND SETTING TIME FOR RESPONSES

On October 17, 2025, Union Electric Company d/b/a Ameren Missouri filed a tariff sheet to reflect changes in the company's Purchased Gas Adjustment. The tariff sheet bears an effective date of November 1, 2025, and has been assigned Tracking No. JG-2026-0057.

In consideration of the effective date of the tariff sheet, the Commission will direct the Staff of the Commission (Staff) to file an expedited recommendation and will establish a deadline for any other entity to file a response to the tariff sheet and/or Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation concerning the above-referenced tariff sheet no later than October 27, 2025.
2. Any other responses concerning Spire's tariff sheet or Staff's recommendation shall be filed no later than October 27, 2025.
3. This order shall be effective when issued.
