STAFF'S MOTION FOR ONE DAY EXTENSION OF TIME TO FILE PROPOSED PROCEDURAL SCHEDULES

Comes now the Staff of the Missouri Public Service Commission ("Staff"), thorough the Staff Counsel Office, and requests an additional day's extension of time for the filing of proposed procedural schedules in File Nos. ER-2010-0355 and ER-2010-0356. In support thereof, the Staff states as follows:

- 1. On June 11, 2010 in separate Order And Notices in File Nos. ER-2010-0355 and ER-2010-0356, the Commission ordered the parties to file proposed procedural schedules by July 20, 2010.
- 2. On July 19, 2010 Kansas City Power & Light Company ("KCPL") in File No. ER-2010-0355 and KCP&L Greater Missouri Operations Company ("GMO") in File No. ER-2010-0356 filed Motions For Extension To Time To File Procedural Schedule requesting until July 27, 2010 to file proposed procedural schedules.
- 3. On July 20, 2010 the Commission in separate Orders in File Nos. ER-2010-0355 and ER-2010-0356 granted the requested one week extensions of time.
- 4. The parties have utilized the additional week for various conference calls and exchanges of proposed schedules and language. Parties that have attended those conference calls

and may have engaged in those discussions include KCPL, GMO, the Office of the Public Counsel ("Public Counsel"), "Industrial Intervenors" (i.e., Midwest Energy Users Association, Praxair, Inc., Ag Processing, Inc., and Sedalia Industrial Energy Users Association), U.S. Department Of Energy, Missouri Retailers Association ("MRA"), Missouri Department of Natural Resources, AARP, Consumers Council of Missouri, Dogwood Energy LLC, The Empire District Electric Company, Missouri Gas Energy, Union Electric Company d/b/a AmerenUE, and the Staff. The Staff, KCPL, GMO, Public Counsel, Industrial Intervenors, and MRA, which were still talking with each other at 5:00 p.m. today, (1) believe they are close to reaching agreement on procedural schedules for File Nos. ER-2010-0355 and ER-2010-0356 and (2), as a consequence, think they should be able to file, and possibly other parties may be able to join in the filing of, sometime on July 28, 2010, proposed procedural schedules for the Commission's consideration.

5. Parties have vigorously pursued agreement on the matter of procedural schedules and related items. The Staff and other parties do not frivolously seek an additional day to submit proposed procedural schedules in File Nos. ER-2010-0355 and ER-2010-0356.

Wherefore the Staff submits this request for an additional extension of time of one day from July 27, 2010 to July 28, 2010 to file proposed procedural schedules in File Nos. ER-2010-0355 and ER-2010-0356.
