ORDER WITHDRAWING ORDER CANCELLING REGISTRATION

On October 23, 2025, the Commission issued an order granting the request to cancel Stoutland Telephone Company's registration to provide Interconnected Voice over Internet Protocol (IVoIP) services effective as of November 2, 2025. On October 24, 2025, Stoutland Telephone Company filed a response indicating its request was to have the cancellation effective January 1, 2026, or as of the effective date of the company's requested FCC order. Specifically, Stoutland Telephone Company requests that its IVoIP registration be cancelled on the same timeline as Case No. IM-2026-0079, which involves related corporations.

The order granting the cancellation of IVoIP registration of Stoutland Telephone Company was entered in error; therefore, the Commission will withdraw that order.

THE COMMISSION ORDERS THAT:

1. The *Order Cancelling Registration* issued in this case on October 23, 2025, is of no effect and is withdrawn.
2. This order is effective when issued.
