ORDER ESTABLISHING TIME TO RESPOND TO MOTION

On October 21, 2025, the Staff of the Commission (Staff) filed a motion requesting that the Commission cancel the certificate of authority to provide interexchange telecommunications and non-switched local exchange (IXC) service in Missouri of Prime Line Communications d/b/a Prime Link Long Distance, Inc. (Prime Link). Staff's motion stated that Prime Link wishes to cancel the certificate.

The Commission need not hold a hearing, if, after proper notice, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's motion.²

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing.
