STAFF'S COMPLIANCE TARIFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, and respectfully states as follows:

- 1. On August 27, 2024, Confluence Rivers Utility Operating Company, Inc. ("Confluence") and Missouri-American Water Company ("MAWC") jointly filed an application with the Missouri Public Service Commission ("Commission") for Confluence to acquire nineteen (19) wastewater systems owned by MAWC.
- 2. On December 30, 2024, Staff recommended that the Commission approve the abovementioned acquisition.
- 3. Following litigation, the Commission approved the acquisition on August 20, 2025, in its *Report and Order*.
- 4. On October 15, 2025, in compliance with the Commission's *Report and Order*, MAWC filed a tariff revision (Tracking No. JS-2026-0054).
- 5. On that same day, the Commission ordered Staff to file a recommendation for MAWC's compliance tariff sheets no later than October 30th, 2025.
