
1. On October 19, 1999, the Staff filed its Staff Recommendation to Grant Certificate of Convenience and Necessity ("Staff Recommendation")
2. The Staff Recommendation suggested that Applicant be granted a certificate of convenience and necessity, that residential rates be approved, that Applicant be ordered to submit a tariff for sewer services, that depreciation rates be approved, that Applicant keep its books and records in accordance with the Uniform System of Accounts and that the Commission reserve the right to consider ratemaking treatment of various matters.
3. Applicant agrees with the recommendations made by Staff.
