#### ORDER APPROVING TARIFF REVISION

Issue Date: October 31, 2025 Effective Date: November 14, 2025

On October 15, 2025, Missouri-American Water Company (MAWC) filed a tariff revision, Tracking No. JS-2026-0054, to comply with the Commission's August 20, 2025, *Report and Order* authorizing Confluence Rivers Utility Operating Company, Inc. to purchase 19 small sewer systems from MAWC. That tariff revision bears an effective date of November 14, 2025. The Commission directed its Staff (Staff) to file a recommendation about the tariff revision and set a deadline for other tariff responses. Staff filed a recommendation to approve the tariff revision. No other responses were received.

The Commission has reviewed the tariff revision and Staff's recommendation and finds that the tariff revision should be approved. The Commission will approve MAWC's tariff revision to become effective on November 14, 2025. Accordingly, the Commission finds it reasonable to make this order effective in less than 30 days so that the order will be effective concurrently with the compliance tariff revision.

#### THE COMMISSION ORDERS THAT:

1. MAWC's tariff revision, assigned Tracking No. JS-2026-0054, is approved to become effective on November 14, 2025.
