ORDER APPROVING TARIFF REVISION

Issue Date: October 31, 2025

Effective Date: November 13, 2025

On October 14, 2025, Missouri-American Water Company (MAWC) filed a tariff revision, Tracking No. JW-2026-0053, to comply with the Commission's September 10, 2025, order granting MAWC a Certificate of Convenience and Necessity for a portion of Johnson County PWSD No. 3. That tariff revision bears an effective date of November 13, 2025. The Commission directed its Staff (Staff) to file a recommendation about the tariff revision and set a deadline for other tariff responses. Staff filed a recommendation to approve the tariff revision. No other responses were received.

The Commission has reviewed the tariff revision and Staff's recommendation. The Commission finds that tariff revision should be approved. The Commission will approve MAWC's tariff revision to become effective on November 13, 2025. Accordingly, the Commission finds it reasonable to make this order effective in less than 30 days so that the order will be effective concurrently with the compliance tariff revision.

THE COMMISSION ORDERS THAT:

1. MAWC's tariff revision, assigned Tracking No. JW-2026-0053, is approved to become effective on November 13, 2025.

2. This order shall become effective on November 13, 2025.

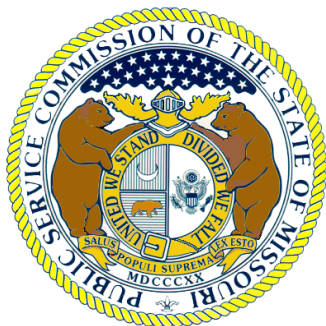
