The Commission opened this file on December 16, 2020, as a working case to gather information about the possible amendment of the Commission's rule on reporting requirements for electric utilities and rural electric cooperatives. As part of the order opening the file, the Commission ordered that anyone wishing to submit comments do so by February 16, 2021. On February 12, Union Electric Company d/b/a Ameren Missouri filed a motion asking that the date for submission of comments be extended by two weeks. The Commission will grant that request.

1. The time allowed for the filing of comments in this matter is extended to March 2, 2021.
2. This order shall be effective when issued.

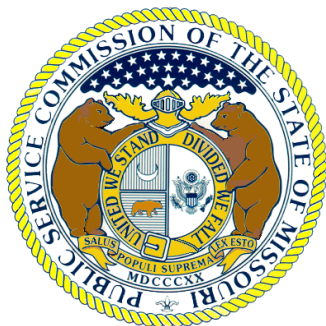
