ORDER DIRECTING JOINT PROPOSED SCHEDULE FOR EVIDENTIARY HEARING

On September 23, 2020, Rachael Staude and Grand Property Management KC filed a complaint against Every Metro, Inc. d/b/a Evergy Missouri Metro. On October 26, 2020, Evergy Missouri Metro filed its answer and affirmative defenses. On January 15, 2021, the Staff of the Missouri Public Service Commission filed its report, and Rachael Staude and Grand Property Management KC responded on January 25, 2021. This file appears ready to proceed to an evidentiary hearing.

In order to expedite the development of a procedural schedule and in light of the current social distancing restrictions, the Commission will direct the parties to jointly propose a procedural schedule. Staff will be responsible for filing the joint proposed procedural schedule.²

The Commission requests the parties include the following as part of a proposed procedural schedule leading to an evidentiary hearing:

- Submission of a Joint Stipulation of Facts;
- Whether there will be prefiled testimony and applicable deadlines;
- Whether there will be post-hearing briefs and applicable deadlines;
- Submission of List of Issues and Order of Hearing Components, and
 Position Statements at least four days in advance of the hearing;
- At least two settlement conferences;
- Allowance for ten business days for transcript preparation;
- An evidentiary hearing held via WebEx.

Any request for expedited hearing transcripts must be made before the procedural schedule is established.

THE COMMISSION ORDERS THAT:

- 1. On or before March 19, 2021, Staff shall submit a joint proposed schedule as described in this order.
 - 2. This order shall be effective when issued.
