This order required the Commission's Staff to file a recommendation regarding Spire Missouri, Inc.'s application or a status report indicating when it expects to file a recommendation no later than February 19, 2021. On February 18, 2021, Staff filed a Status Report requesting the Commission approve Staff's anticipated April 19, 2021, date for filing its recommendation. The Commission will do so.

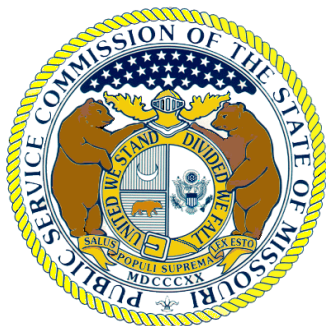
