# ORDER CANCELLING CERTIFICATE OF CONVENIENCE AND NECESSITY OF FRANKLIN COUNTY WATER COMPANY, INC.

On July 10, 2019, the Commission issued an Order Approving Transfer of Assets and Granting Certificate of Convenience and Necessity (Order). The order authorized Franklin County Water Company Inc. (Franklin County Water) to sell and transfer utility assets located in Franklin County, Missouri, to Liberty Utilities (Missouri Water) LLC (Liberty Utilities). It granted Liberty Utilities a Certificate of Convenience and Necessity (CCN) to provide Franklin County, Missouri, water service. The order authorized Franklin County Water to transfer its Certificate of Convenience and Necessity (CCN) to Liberty Utilities and to cease providing service. The order did not contemplate that a CCN in Franklin County Water's name would continue to exist, but did not explicitly cancel that CCN. The Commission will now explicitly cancel the CCN that was held by Franklin County Water Company, Inc.

#### THE COMMISSION ORDERS THAT:

The Certificate of Convenience and Necessity of Franklin County Water
 Company, Inc., is cancelled.
