## ORDER FURTHER SUSPENDING PROCEDURAL SCHEDULES AND DIRECTING THE FILING OF STATUS REPORTS OR SETTLEMENT AGREEMENTS

On January 29, 2021, the Commission suspended the procedural schedules in these files to allow for continued settlement negotiations. On February 19, 2021, the Commission's Staff filed its second status report in each file indicating that the parties are nearly in agreement on the base amounts, and Staff is completing its review. Staff requests that the Commission continue the suspension of the procedural schedules and order the parties to file additional status reports or settlement agreements by March 1, 2021.

The Commission will further suspend the procedural schedules and will order that status reports or settlement agreements be filed no later than March 1, 2021.

### THE COMMISSION ORDERS THAT:

1. The procedural schedules are further suspended.

2. The parties shall file status reports or settlements no later than March 1, 2021.

3. This order is effective when issued.

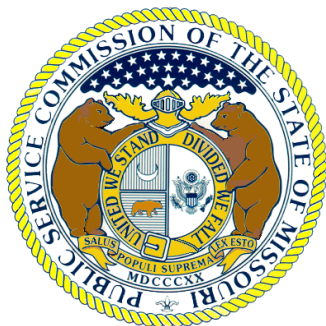

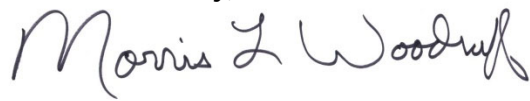
