ORDER ALLOWING INTERVENTION

On January 12, 2021, Spire Missouri Inc. (Spire or the Company) filed an Application For Certificate of Convenience and Necessity for Barry County and Request for Waiver (Application) with the Missouri Public Service Commission (Commission) requesting permission and approval for a certificate of convenience and necessity (CCN) to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in Barry County, Missouri, as a further expansion of its existing certificated area.¹ On February 12, 2021, Summit Natural Gas of Missouri, Inc. (SNGMO) filed an application to intervene. SNGMO states it has a “line only” certificated service territory in parts of Barry County and, thus, its interest in this matter is different from that of the general public and cannot be represented adequately by any other party to this proceeding. No party objected to the SNGMO’s application. The Commission finds that the interests of SNGMO differ from those of the general public and may be adversely affected by a final order arising from this case. Further, the

Commission finds that granting the proposed intervention will serve the public interest.¹
Therefore, the Commission will grant the application to intervene.

THE COMMISSION ORDERS THAT:

1. The application to intervene of Summit Natural Gas of Missouri, Inc., is granted.
2. This order shall be effective when issued.

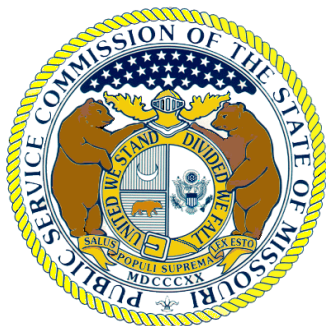
