# ORDER MODIFYING PROCEDURAL SCHEDULE

On March 20, 2002, the Staff of the Commission filed a pleading requesting that the Commission revise the existing procedural schedule. That procedural schedule - established on April 2, 2001 - leads to a hearing beginning on September 30, 2002. Staff indicates that it will be extremely difficult to complete its audits within the existing procedural schedule. Staff proposes that the procedural schedule be revised to lead to a hearing beginning on March 18, 2003. The motion indicates that Staff has consulted with counsel for United Cities Gas Company, and with counsel for the Office of the Public Counsel, and that neither objects to the requested modification of the procedural schedule.

Staff's request to modify the procedural schedule is reasonable and is not opposed by any party. The request will be granted.
