JOINT MOTION TO RESCHEDULE PRE-HEARING CONFERENCE



This short delay will not prejudice any of the Parties nor will it effect any settlement discussions.


WHEREFORE the Parties respectfully request that the Commission reschedule the prehearing conference for February 18th at 10:00 a.m.


