SUBJECT: Staff Recommendation on Tariff Sheets Filed to Comply with the Commission's ORDER APPROVING STIPULATION AND AGREEMENT, Issued May 4, 1999.

DATE: June 28, 1999

On June 3, 1999, Laclede Gas Company (Laclede or Company) of St. Louis, Missouri filed tariff sheets with the Missouri Public Service Commission (Commission) to comply with the Commission's ORDER APPROVING STIPULATION AND AGREEMENT (Order), issued on May 4, 1999. On June 10, 1999, Laclede filed substitute tariff sheets to correct typographical errors. On June 25, 1999, Laclede filed substitute tariff sheets to incorporate changes suggested by Staff and Union Electric Company d/b/a AmerenUE (AmerenUE).

On April 13, 1999, AmerenUE and Laclede entered into a STIPULATION AND AGREEMENT setting territorial boundary lines in areas around the City of Wentzville, Missouri (Wentzville). ORDERED: 7 of the Commission's Order states, "Union Electric Company d/b/a AmerenUE and Laclede Gas Company shall file tariffs reflecting the changes approved in this Order no later than June 3, 1999. The tariffs shall reference these case numbers and shall briefly describe the territorial boundary lines established by this Order."

On June 2, 1999, AmerenUE also filed (File No. 9900945) a tariff sheet which proposes similar changes to its territorial boundary lines.

The Commission's Gas Department - Tariffs/Rate Design Staff (Staff) has reviewed this filing and is of the opinion that it is in compliance with the Commission's Order. Other than File No. 9900945, the Staff is unaware of any issue currently pending before the Commission which affects or is affected by this filing. Therefore, Staff recommends that the following tariff sheet filed on June 3, 1999, and as substituted on June 10, 1999, and on June 25, 1999, be approved to become effective for service on and after July 4, 1999, the requested effective date:
