

ORDER APPROVING TARIFF FILED IN COMPLIANCE WITH COMMISSION ORDER

On May 4, 1999, the Commission approved a stipulation and agreement filed by the Staff of the Public Service Commission (Staff), Union Electric Company d/b/a AmerenUE (UE), Laclede Gas Company (Laclede), Missouri Pipeline Company, and the Office of the Public Counsel (Public Counsel). The stipulation and agreement resolved a dispute between UE and Laclede regarding their respective service territories. Certificates of Convenience and Necessity were issued to both UE and Laclede, allowing the two companies to serve specified areas

in St. Charles County. The Commission's order directed UE and Laclede to file tariffs reflecting the revised service areas. UE filed tariff sheets on June 2, with an effective date of July 2, reflecting the revised territorial boundary lines approved in the Commission's order of May 4. The Commission's Staff reviewed the tariff sheets and filed a memorandum on June 29, indicating that the submitted tariff filing is in compliance with the Commission's order of May 4. The memorandum recommends that the Commission approve the submitted tariffs effective on July 2, the requested effective date.

The Commission has reviewed the tariff sheets and Staff's recommendation and finds that the tariff sheets, as amended, conform to the Commission's order of May 4 and should be approved to become effective on July 2.

IT IS THEREFORE ORDERED:

1. That the tariff filed by Union Electric Company d/b/a AmerenUE on June 2, 1999, and assigned tariff number 9900945, is approved to become effective on July 2, 1999. The tariff approved is:
