ORDER CANCELLING CERTIFICATE OF SERVICE AUTHORITY

Issue Date: November 10, 2025 Effective Date: November 20, 2025

On October 21, 2025, the Staff of the Commission (Staff) filed a motion requesting that the Commission cancel the certificate of service authority to provide interexchange telecommunications and non-switched local exchange (IXC) service in Missouri of Prime Line Communications d/b/a Prime Link Long Distance, Inc. (Prime Link). The Commission granted Prime Link America a certificate in Case No. TA-97-320. Staff's motion states that Prime Link stated that it wished to voluntarily relinquish its IXC service authority.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo (2016), which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

The Commission issued notice and allowed time to request a hearing. There were no responses. The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, the Commission may cancel the certificate based on Staff's motion.

Based on Staff's motion, the Commission finds that the certificate of service authority granted to Prime Link shall be cancelled.

THE COMMISSION ORDERS THAT:

- 1. The certificate of service authority issued to Prime Line Communications d/b/a Prime Link Long Distance, Inc. to provide interexchange telecommunications and non-switched local exchange service in the state of Missouri is cancelled.
 - 2. This order shall be effective November 20, 2025.
 - 3. This case shall close November 21, 2025.
