

SECOND ORDER NAMING PARTICIPANTS OF THE
NATURAL GAS COMMODITY PRICE TASK FORCE

On March 15, 2001, the Commission issued its first Order Naming Participants of the Natural Gas Commodity Price Task Force. This order noted that the Commission had received applications to participate on the Task Force from numerous entities and individuals. The Commission allowed each of the entities or individuals to participate on the Task Force. Some of the entities requesting to participate on the Task Force had either not named a particular person to represent them, or had nominated several persons. Therefore, the Commission directed these entities to file a letter no later than March 26, 2001, nominating one person to represent each entity on the Task Force: Atmos Energy Corporation; Fidelity Natural Gas, Inc.; Laclede Gas Company; Office of the Public Counsel; and Southern Missouri Gas Company, L.P.

On March 20, 2001, the Office of the Public Counsel nominated Martha S. Hogerty to be the Public Counsel's representatives. Michael Pendergast filed a letter on March 23, 2001, indicating that he will represent Laclede Gas Company on the Task Force.

On March 27, 2001, Atmos Energy Corporation, through its United Cities Gas Company and Greeley Gas Company Divisions,

designated Pat Childers to represent it on the Task Force. On the same date, Fidelity Natural Gas, Inc., nominated David Beier as its representative, and Southern Missouri Gas Company, L.P., designated its counsel, James M. Fischer, as its representative on the Task Force.

IT IS THEREFORE ORDERED:

1. That Martha S. Hogerty shall represent the Office of the Public Counsel on the Natural Gas Commodity Price Task Force.

2. That Pat Childers shall represent Atmos Energy Corporation on the Natural Gas Commodity Price Task Force.

3. That David Beier shall represent Fidelity Natural Gas, Inc., on the Natural Gas Commodity Price Task Force.

4. That Michael Pendergast shall represent Laclede Gas Company on the Natural Gas Commodity Price Task Force.

5. That James M. Fischer shall represent Southern Missouri Gas Company, L.P., on the Natural Gas Commodity Price Task Force.

6. That this order shall become effective on April 19, 2001.
