On March 21, 2024, the Commission issued its *Order Approving Stipulation and Agreement and Granting Certificates of Convenience and Necessity* (Order). Paragraph 5.j. of the Stipulation and Agreement contained notice and reporting requirements for Union Electric Company d/b/a Ameren Missouri for any projects used as a resource in its Renewable Solutions Program approved by the Commission in Case No. EA-2022-0245.

On November 12, 2025, Ameren Missouri filed a tariff sheet to establish rates for Phase 3 of its Renewable Solutions Program, using the Vandalia and Bowling Green solar facilities as resources. The tariff sheet bears an effective date of December 12, 2025, and has been assigned Tracking No. JE-2026-0068.

The Commission will direct its Staff to file a recommendation as to whether the tariff sheet complies with its Order and set a deadline for responses.

THE COMMISSION ORDERS THAT:

1. No later than November 19, 2025, Staff shall file a recommendation regarding Ameren Missouri's tariff sheet filed November 12, 2025 (Tracking No. JG-2026-0068).

- 2. Any party wishing to respond to Ameren Missouri's tariff sheet filing or to Staff's recommendation shall do so no later than November 20, 2025.
 - 3. This order shall be effective when issued.
