ORDER DIRECTING EXPEDITED STAFF RECOMMENDATION ON TARIFF SHEETS AND SETTING TIME FOR RESPONSES

On November 12, 2025, Spire Missouri Inc. d/b/a Spire filed tariff sheets to reflect changes in the company's Purchased Gas Adjustment for its eastern Missouri and western Missouri operating divisions. The tariff sheets bear an effective date of November 26, 2025, and have been assigned Tracking No. JG-2026-0069.

The Commission will direct the Staff of the Commission (Staff) to file a recommendation on an expedited basis and will establish a deadline for any other entity to file a response to the tariff sheets and/or Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation concerning the above-referenced tariff sheet no later than November 20, 2025.
2. Any other responses concerning Spire's tariff sheet or Staff's recommendation shall be filed no later than November 20, 2025.
3. This order shall be effective when issued.

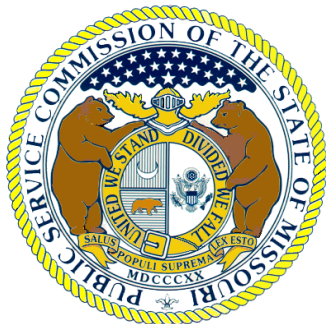
