ORDER SHORTENING TIME FOR RESPONSES

On October 30, 2020, Spire Missouri Inc. (Spire) filed its *Verified Application of Spire Missouri Inc. for Approval to Establish an On-Bill Financing Program and Cost Recovery Mechanism for its Missouri Service Territory and Request for Waiver from 60 Day Notice Rule* (Application) along with direct testimony and revised tariff sheets. The Application seeks approval of a new tariffed program, an on-bill financing program, and an associated cost recovery mechanism. The tariff sheets, Tariff Nos. YG-2021-0112 and YG-2021-0113, bore an effective date of November 29, 2020. The Commission suspended the tariff sheets until January 28, 2021. After a request for additional time for Staff to file its recommendation, the tariff sheets were further suspended until March 29, 2021.

Staff filed its recommendation on February 26, 2021. Staff recommended the Commission reject the tariff sheets and address these proposals in Spire's currently pending general rate proceeding, File No. GR-2021-0108, in which similar tariff sheets have been filed. So that the Commission has adequate time before the effective date of the tariff sheets to consider responses to Staff's recommendation and any other response or objections, the Commission will shorten the response time to Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. Any response to Staff's recommendation shall be filed no later than March 5, 2021.
2. This order shall be effective when issued.
