ORDER DIRECTING STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

On February 26, 2021, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty (MNG) filed proposed revisions to its Weather Normalization Adjustment Rider (WNAR) tariff sheets in Tariff Tracking Number JG-2021-0162. Liberty projects that the changes to the WNAR tariff sheets will increase the average monthly bill of the typical residential customer in its Northwest, West, and Southeast Districts by \$0.67, \$0.62, and \$0.58 respectively. The tariff sheets bear an April 1, 2021, effective date.

The Staff of the Missouri Public Service Commission (Staff) will be directed to file a recommendation. The Commission will establish a deadline for any other entity to file a response to the proposed tariff changes or to the Staff recommendation.

The Commission will also direct Liberty to file a replacement tariff sheet for tariff sheet P.S.C. MO. No. 2, 6th Revised Sheet No. 67.4 as the currently filed tariff sheet shows an effective date of April 1, 2020.

THE COMMISSION ORDERS THAT:

1. No later than March 3, 2021, Liberty shall file a replacement tariff sheet as described in the body of this order.

- 2. No later than March 12, 2021, Staff shall file a recommendation regarding Tariff Tracking No. JG-2021-0162.
- 3. Any other entity wishing to respond to the tariff changes or Staff's recommendation shall do so before noon March 15, 2021.
 - 4. This order is effective when issued.
