ORDER DELAYING THE START OF THE EVIDENTIARY HEARING AND FURTHER EXTENDING THE TIME FOR OBJECTIONS

Issue Date: November 18, 2025 Effective Date: November 18, 2025

On November 18, 2025, Union Electric Company d/b/a Ameren Missouri filed its Unopposed Motion to Cancel an Additional Day of the Evidentiary Hearing and to Further Extend the Objection Deadline for Non-Unanimous Stipulation and Motion for Expedited Treatment. Ameren Missouri states that it has reached an agreement with the Commission's Staff resolving their issues. Ameren Missouri asks for additional time to finalize details of a new or superseding stipulation and agreement. Ameren Missouri notes that it is still discussing resolutions with the Office of the Public Counsel, but they have not reached an agreement.

The Commission previously canceled the first two days of the evidentiary hearing and extended the deadline for objections to the *Corrected Non-Unanimous Global Stipulation and Agreement* to November 18, 2025.

Commission Rule 20 CSR 4240-2.205 authorizes the Commission to grant a variance to the seven-day objection deadline contained in Commission Rule 20 CSR 4240-2.115 for good cause. The Commission finds good cause to grant an additional extension because the parties are continuing efforts to resolve this case through

settlement, and the request is reasonable. The Commission will also cancel one day of the evidentiary hearing.

THE COMMISSION ORDERS THAT:

- 1. The evidentiary hearing set to begin on November 19, 2025, is delayed to November 20, 2025. Wednesday, November 19, 2025, is canceled. The evidentiary hearing shall now start on November 20, 2025, beginning at 9:00 a.m. in room 310 of the Governor Office Building.
- 2. The deadline for objections to the *Corrected Non-Unanimous Global Stipulation and Agreement* is extended to November 19, 2025.
 - 3. This order is effective when issued.
