SECOND ORDER GRANTING EXTENSION OF TIME FOR RESPONSES AND REQUESTS FOR HEARING

On February 5, 2021, the Staff of the Commission filed its *Staff Report* in which it recommended that the Commission approve Union Electric Company d/b/a Ameren Missouri's application for a certificate of convenience and necessity with certain conditions. The Commission directed that responses to the report and requests for hearing should be filed no later than February 22, 2021.

On February 18, 2021, Ameren Missouri requested a two-week extension of time to file its response. Ameren Missouri stated that the extension would give it time to seek clarification with the Staff of the Commission about some of Staff's recommended conditions to granting Ameren Missouri's application. That extension was granted and responses were ordered to be filed no later than on March 8, 2021.

On March 8, 2021, Ameren Missouri filed a second request for additional time. Ameren Missouri states that it and Staff have reached an agreement regarding the conditions and need additional time to put their agreement in writing and circulate it to the other parties. The Commission will grant the extension.

THE COMMISSION ORDERS THAT:

1. Any responses to the *Staff Report* filed on February 5, 2021, and any objections to the application or requests for hearing shall be made no later than March 15, 2021.
2. This order shall be effective when issued.
