MOTION FOR WITNESS TO APPEAR REMOTELY

COMES NOW Amazon Data Services, Inc. (“ADS”) and requests permission for its witness, Dr. Albert W. Bremser, to appear remotely at the Evidentiary Hearing in this matter. In support of this request, ADS states as follows:

1. This matter was originally set for an evidentiary hearing November 17-21, 2025. On November 13, 2025, the Commission granted an Unopposed Motion to Partially Suspend Evidentiary Hearing, and on November 18, the Commission granted issue an Order Further Cancelling Evidentiary Hearing such that the evidentiary hearing is currently set for November 20-21, 2025.

2. ADS intends to present one witness at the hearing— Dr. Albert W. Bremser.

3. ADS is a signatory to the Corrected Non-Unanimous Global Stipulation and Agreement filed on November 9, 2025 (“Stipulation”). Under the Stipulation’s terms, the signatory parties have waived cross-examination of each other’s witnesses during the evidentiary hearing (save any cross-examination that might occur in response to questions from the bench).

4. Dr. Bremser lives outside of the State of Missouri. Due to the uncertainty, inconvenience, and expense of travel and the low likelihood of extensive cross-examination for Dr. Bremser, ADS requests that Dr. Bremser

be permitted to appear remotely.

5. ADS's legal counsel still intends to appear in-person at the evidentiary hearing.

6. ADS requested feedback and has not heard any objection to this request from other parties.

WHEREFORE, Amazon Data Services, Inc. respectfully requests the Commission grant this Motion for Dr. Albert W. Bremser to appear remotely and for such other relief as is deemed proper under the circumstances.
