ORDER GRANTING APPLICATION TO INTERVENE

On December 21, 2020, Mr. Carl Richard Mills filed a letter initiating a staff-assisted rate case. On January 20, 2021, the Commission set a local public hearing, which was conducted on February 2, 2021. On February 10, 2021, Mr. Derald Morgan filed an application to intervene in this case. The Commission directed that any responses to Mr. Morgan's application be filed no later than February 24, 2021. No objections have been filed.

Mr. Morgan's application asserts that Mr. Morgan's interests are different from the general public and could be adversely affected by a final order in this case because Mr. Morgan receives water service from the system operated by Mr. Mills. Mr. Morgan also contends granting the intervention application will serve the public interest.

The Commission may grant a motion to intervene (1) when the proposed intervenor's interest is different from the general public and may be adversely affected by a final order in the case, or (2) when the Commission determines granting the proposed intervention will serve the public interest.¹

The Commission finds allowing Mr. Morgan to intervene will serve the public interest by providing additional information for the Commission's decision. Mr. Morgan's unopposed application to intervene will be granted.

THE COMMISSION ORDERS THAT:

1. Mr. Morgan's application to intervene is granted.
2. This order shall be effective when issued.
