ORDER DIRECTING EXPEDITED STAFF RECOMMENDATION AND SETTING TIME FOR ANY RESPONSES TO TARIFF FILING

On March 16, 2021, Union Electric Company d/b/a Ameren Missouri filed a tariff sheet to reflect changes in the company's Purchased Gas Adjustment (PGA) clause and Actual Cost Adjustment for its Missouri gas operations. The tariff sheet bears an effective date of April 1, 2021.

In consideration of the requested effective date of the tariff sheets, the Commission will direct the Staff of the Missouri Public Service Commission to file a recommendation on an expedited schedule. The Commission will also establish a deadline for any other entity to file a response to the tariffs.

THE COMMISSION ORDERS THAT:

1. No later than 3:30 p.m. on March 22, 2021, the Commission's Staff shall file a recommendation with regard to the tariff sheet filed by Ameren Missouri, Tariff No. YG-2021-0169.
2. Any other person or entity wishing to comment on Ameren Missouri's PGA tariff filing shall file a response no later than 3:30 p.m. on March 22, 2021.
3. This order is effective when issued.
