On November 24, 2025, the Staff of the Commission (Staff) filed its recommendation with attached memorandum regarding The Empire District Gas Company d/b/a Liberty's (Empire's) 2023-2024 Actual Cost Adjustment filing. Staff listed certain comments, concerns and recommendations as set forth in the Billed Revenue, Actual Gas Cost, Reliability Analysis and Gas Supply Planning, and Hedging sections.

Staff requested that the Commission order Empire to respond within 30 days to Staff's concerns, comments, and recommendations included in the Staff Recommendation and Memorandum.
