On November 20, 2025, EM3 Networks LLC submitted a request to recognize its name change to Capcon Networks LLC. EM3 Networks was granted registration to provide Interconnected Voice over Internet Protocol (VoIP) services in Case No. DA-2017-0307.

The Commission has reviewed the filings and 20 CSR 4240-28.011(2) and finds the company has complied with all statutory and regulatory requirements for changing its name. The Commission will recognize the name change.

The Commission finds it reasonable for this order to become effective in less than 30 days.
