MOTION TO CONSOLIDATE

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), through counsel, and moves the Commission for an order consolidating Case Nos. EO-2025-0323 and EO-2025-0324. Staff states the following in support of this motion:

1. On June 2, 2025, Staff filed notice that on that date, it started its third prudence review of costs associated with Evergy Missouri West Inc.’s (Evergy Missouri West) and Evergy Metro, Inc.’s (Evergy Missouri Metro) Cycle 3 energy efficiency programs and its first MEEIA prudence review of the costs associated with its Cycle 4 energy efficiency programs. These dockets are assigned case numbers EO-2025-0323 and EO-2025-0324.

2. Commission Rule 20 CSR 4240-2.110(3) allows the Commission to consolidate pending actions involving related questions of law or fact.¹

3. There are common questions of law and fact in the above-referenced cases, and their consolidation would be administratively expedient and simplify filings.

4. Counsel for Evergy Missouri West and Evergy Missouri Metro has been notified of this request and consents to the granting of this Motion.

WHEREFORE, Staff requests that the Commission issue an order consolidating Case Nos. EO-2025-0323 and EO-2025-0324, with Case No. EO-2025-0323 being the lead case in which all pleadings are filed and for any other such orders as the Commission deems just and reasonable.
